Wind Lake Management District Board of Commissioner Meeting  
January 24, 2013

Present: J. Marks, R. Schopp, R. Mohr, G. Kotsiris, J. Bellante, K. Aron, and 2 citizens.  
J. Marks called the board meeting to order at 7:30 pm.

R. Schopp moved to approve the minutes, second by R. Mohr, motion carried.

R. Mohr presented the treasurers report. R. Schopp moved to accept the treasurer's report as presented, 2<sup>nd</sup> by G. Kotsiris, motion carried. R. Schopp moved to pay R Mohr \$50 for the spud bar, 2<sup>nd</sup> by G. Kotsiris, motion carried.

#### INFORMATION AND CORRESPONDENCE

The district's copier is getting old. The copier company won't issue any more service contracts, because the parts may not be available. It has been working fine and hopefully it will continue to.  
There is a \$51,000 loan payment due in March on the Alum treatment and the property loan.

#### PUBLIC COMMENTS

None

#### OLD BUSINESS

The board discussed the 2013 harvesting schedule and proposed contract from Midwest Aquatics. The lake is back up to its normal winter level, which is 6 inches down from the top of the dam. G. Kotsiris moved to contract Midwest Aquatics for the first couple of weeks of harvesting and the rest to go to Clearwater Harvesters, 2<sup>nd</sup> by R. Schopp, motion carried.

The board discussed the lack of progress with the Drainage District, including insurance. The court hearing is coming up. We have now received confirmation from the insurance company underwriter for the Drainage District, that the insurance does NOT cover the dam operation. Further operation by WLMD places the district at risk should someone file a claim, warranted or not. G. Kotsiris moved to notify all parties immediately that WLMD will cease all dam operations effective immediately, 2<sup>nd</sup> by R. Schopp. Motion carried unanimously with J. Marks and R. Mohr abstaining due to conflict. G. Kotsiris moved that excessive insurance costs would be cause for nullifying/backing out of contract with the County and the Drainage District, 2<sup>nd</sup> by R. Mohr, motion carried, with J. Marks abstaining.

The roadside weed pickup was discussed. The proposals were \$500 and \$900, and based on the material picked up last year, the suggestion was to flip the schedule, with more pickups early in the season. After discussion, G. Kotsiris moved to use the same contractor to do 12 pickups, with 2 in April, 3 in May, 3 in June, and 2 in July and August., 2<sup>nd</sup> by R. Mohr, motion carried.

The hearing for the rezoning of the Papp property will be February 18 at the County. The town hearing will be March 6.

#### NEW BUSINESS

J. Marks informed the board that there is discussion of charging for fire/rescue calls in the town.

The meeting adjourned at 8:40 pm. The next board meeting of the WLMD is scheduled for February 28, 2013.

#### INFORMATION AND CORRESPONDENCE

R. Schopp informed the board that he will not be able to make the March 28<sup>th</sup> meeting.  
The board discussed the property maintenance on S. Wind Lake Rd. The current cost for mowing is \$500 for every two weeks. Naturescape will spray for weeds for \$259, and charges \$48 a mowing. Between 12 and 14 cuttings are needed. This will be discussed further in March.  
WLMD received two assessment notices from the Norway Dover Drainage District. The wetland parcel will be protested prior to March 28, 2013.  
The Town did not waive the application fee for the rezoning.

#### PUBLIC COMMENTS

A resident commented that the board is struggling to deal with the budget issues, and may need to consider raising the annual charge by even \$20.

#### OLD BUSINESS

The board discussed the 2013 harvesting schedule and contract from Midwest Aquatics, and Clearwater's schedule is all set. The only question is having Clearwater come May 28, or wait until June 24 to cover for the 4<sup>th</sup> of July. > Aron will check with Clearwater to see if we have that as an option.  
R. Schopp moved to have R. Mohr be the primary supervisor when Midwest is on the lake, with J. Marks as backup; for \$25/hour compensation and mileage. Second by R. Mohr, motion carried.

J. Marks read a statement explaining his position on the dam operation and insurance and that he disagreed with K. Aron. K. Aron explained that a tentative solution had been reached during a meeting earlier in the day with the attorneys for the Drainage District, the County and WLMD. R. Schopp moved to approve the following:

- The recommendation that the County re-assume the role of Operator/Owner of the Dam;
- The recommendation that the County immediately hire Jim Marks to operate the Dam until the final details of the paperwork and long-term staffing are resolved. This was noted as important because the lake level change to the summer level begins today;
- The WLMD strongly recommends that the County hire Jim Marks for the long-term operation of the Dam, and backup operator Richard Mohr;
- The annual payment of \$6,000 to the County to assist with the operation of the Dam.
- The revision of the Dam Operation Agreement to reflect the new status.

Second by G. Kotsiris, Motion carried, with J, Marks and R. Mohr abstaining.  
The lake will begin to return to the summer level between Mar 1 and Mar 15.

#### NEW BUSINESS

Because of a conflict, it was discussed moving the Annual Meeting date from Sept 12 to Sept 5. R. Schopp moved to the change the date to Sept 5, 2013, second by R. Mohr, motion carried.

The meeting adjourned at 8:55 pm. The next board meeting of the WLMD is scheduled for March 28, 2013.

The Dam operation was discussed. The County needs to respond regarding the offer of the WLMD and Drainage District to turn over operation money in exchange for hiring someone.

Kosiris offered a couple of other options, including offering to pay for monitoring if the County will hire J. Marks; or considering some type of seasonal control; or asking the judge to allow us to pay nothing and be completely released from the agreement; or, allow the original agreement to stand as is, with WLMD requiring J. Marks to be incorporated. The board agreed to send the options to the attorney and meet with him to discuss.

#### NEW BUSINESS

R. Mohr asked about selling the S Wind Lake Rd. lot to boost the budget. He is concerned about the declining cushion in the WLMD budget. K. Aron will compile preliminary budget numbers for the next meeting.

The board discussed the harvesting program and whether there was a need for 2 more weeks of harvesting. J. Bellante said he absolutely does not approve of cancelling any weeks of cutting. He referenced Browns Lake program. He said the costs of even more harvesting should be presented to the Annual Meeting. Two board members think only 1 of the 2 remaining weeks of cutting are needed. Based on the discussion, the next week of harvesting, July 22<sup>nd</sup>, will take place as planned.

The board discussed the current status of the agreement with the drainage district and the county about the operation of the dam. G. Kotsiris moved to ask J. Marks to form an LLC to insulate the District from liability, 2<sup>nd</sup> by R. Schopp, motion carried.

#### NEW BUSINESS

The board discussed the legal defense fund and the lack of contributions. R. Schopp moved to use the fund to pay current legal fees and then eliminate the line item from the budget, 2<sup>nd</sup> by R. Mohr, motion carried.
