**Minutes**

**1. Call Meeting to Order and Pledge of Allegiance**

Meeting Called to Order by M Bluemel at 7:00pm followed by Pledge of Allegiance

**2. Approve Minutes for June 23, 2026 Meeting**

-M Bluemel called for a discussion on the May meeting minutes. Flunker motioned to approve the minutes as presented. Calliari seconded the motion. Motion passed 6-0.

**3. Treasurers Report**

-Flunker provided written and verbal reports for the period of June 22<sup>nd</sup> to July 27<sup>th</sup>, 2026. Motion by J Bluemel to approve the treasurer's report as presented, seconded by Calliari. Motion passed 6-0.

**4. Public Comments**

**5. Information and Correspondence**

-M Bluemel noted that he received multiple calls from Tom Halter regarding the dam measurement reading off about 2-3 inches. This has been corrected but readings are off for about a month.

**6. New Business**

**a. Weed Collection and Dumping – Discussion and Possible Action**

-Calliari noted the district received notification that the dump site was at capacity of what could be dumped there. Calliari advised he discussed the situation with several members of the town board and DPW. The consensus was to stop dumping there for a week and haul the weeds currently at the site out. Lyman provided background information on the town dump site and noted it can still be used in the future but the weeds need to be routinely removed. A short discussion amongst the board followed.

-M Bluemel polled the board regarding setting a date for the final roadside weed pickup. A short discussion amongst the board was had. The board consensus was to set the final roadside weed pickup date as 9/18/26.

## **Old Business**

### **a. Starry Stonewort Update – Discussion and Possible Action**

-Bellante noted that the Starry Stonewort treatment was recently completed and include 4 areas totaling 2.6 acres of the lake. A summary of areas treated followed by a short discussion amongst the board followed.

### **b. New Shed – Update**

-Calliari noted the shed will be delivered this coming Monday. A short discussion amongst the board on the details of delivery and installation followed.

### **c. Harvesting Update**

-Jerry Kotarak noted that overall weed harvesting continues to run smoothly. The crew has been working its way around the lake, and he has been receiving positive feedback from residents. Jerry noted how responsive Inland Harvesting has been with any issues that have come. He expressed how grateful he is that Inland has been so good to work with.
